

# MSP<sup>®</sup> Practitioner Re-Registration Pack

All Practitioners who have taken the examination have agreed to this requirement as part of their initial application and so are now designated as Registered Practitioners. By taking the Re-registration examination candidates are able to demonstrate to employers and prospective employers their up to date knowledge and commitment to Continuing Professional Development.
