

PRINCE2® Practitioner Re-Registration Pack



Certification in the PRINCE2® method has become the benchmark standard throughout the project management industry. The most desirable level of certification is the PRINCE2® Registered Practitioner qualification.

The PRINCE2® Manual is periodically revised and enhanced to reflect the latest best practices in project management and the most recent update was in June 2009. As a result, in order to maintain the status of PRINCE2® Registered Practitioner, certificate holders must re-take a re-registration exam every 3–5 years. This one hour examination ensures that registered practitioners are fully up to date with any revisions to the method and can evidence that their knowledge of the method is current.

This is the only qualification scheme aimed at Project Management professionals that is recognised by the UK Accreditation Service (UKAS) in accordance with the requirements of EN 45011 and EN 45013.

The blended learning will provide a comprehensive overview of the recent changes and developments in the PRINCE2® method together with comprehensive and up to date guidance on examination technique. This blended learning course combines the best of e-learning with a 1 day workshop in which the PRINCE2® Practitioner Re-registration examination is taken in. Work your way through the e-learning at your own pace and then book your 1 day workshop when you are ready and within 12 months of purchase.

What's included?

This blended learning course takes candidates through a review of PRINCE2® method and the changes thereto. Candidates are provided with:

- 12 months online access to the **PRINCE2® e-learning course**
- A 1-day classroom revision workshop where you will sit the PRINCE2® re-registration exam (exam fee is included in the price) – can be taken up to 12 months after purchase. Your candidate number from your Practitioner exam will be required when booking your workshop

This re-registration comprises of a 1 hour examination set at the same standard as the Practitioner examination. All Practitioners who have taken the PRINCE2® Practitioner qualification since October 2000 have agreed or are agreeing to this requirement as part of their initial application and so are now designated as Registered Practitioners.

Duration

20–25 hours e-learning followed by a 1 day workshop.

Accreditation

The PRINCE2® Re-Registration exam comprises of an exam paper set at the same standard as the Practitioner examination and is based on the 2009 PRINCE2® Manual.

- Paper Based Exam
- Objective testing examination
- 3 questions per paper with 12 marks available per question – all question items will be worth 1 mark, making the total number of marks available per paper 36
- 1 hour will be allowed (no reading time)
- Open book exam (PRINCE2® manual only)
- The pass mark is 55%. Candidates need a total of 20/36 marks to pass the exam.



Target Audience

- **Practitioners certified prior to October 2000** have the opportunity to take the re-registration examination in order to demonstrate their commitment to professional development. This is particularly important following the recent revisions to the PRINCE2® manual and its greater focus on Business Case and the Management of Risk.
- **Those who have qualified since January 2001** or have voluntarily undertaken the re-registration qualification are designated as Registered Practitioners, which enables employers to be confident with their recency of knowledge and commitment to Continuing Professional Development.
