User Licence

1. Licence

1.1 You are permitted to:

- 1.1.3 use the Product on a computer network provided it has been purchased for such use and no more than the maximum number of copies of the Product are in use on that network at any one time.

1.2 You are not permitted:

- 1.2.1 to load the Product on to a network server for the purposes of distribution to one or more other computer(s) on that network or to effect such distribution;
- 1.2.2 to rent, lease, sub-license, loan, copy, modify, adapt, merge, translate, reverse engineer, decompile, disassemble or create derivative works based on the whole or any part of the Product or its associated documentation or use, reproduce or deal in the Product or any part of it in any way, save only to the extent and in the circumstances expressly permitted by law.

2. Term

- 2.2 We have the right to terminate this user licence with immediate effect if you breach any of the terms of this user licence or if the Licensee breaches any of the terms of the Contract.

- 3.1 We will at all times retain ownership of the Product and all subsequent copies. You have no right, title or interest whatsoever in the Product save for the right to use it for the licence
